Direct Deposit Form Submittal Guide

For security purposes, please do not send electronic tax and direct deposit documents to the Payroll Office via email or fax. The Payroll Office can only accept electronic tax and direct deposit documents through the UNCSA Payroll website secure links and the TalentEd/PeopleAdmin Onboarding portal.

There is not an option to opt-out of direct deposit. Per UNCSA's Direct Deposit Policy #312 (https://www.uncsa.edu/mysa/policy-manual/300-business-administration-finance/312-direct-deposit.aspx), payments paid by Banner Payroll to employees must be made via direct deposit. Only one paper check is permitted to allow sufficient time to submit acceptable documentation for direct deposit to the Payroll Office. If you do not have an account, please visit a local or an online bank to establish/open a bank account in your name. All future payments are required to be direct deposit.

Acceptable forms of documentation include:

- 1. A voided pre-printed check account in your name (current address information is not required)
- 2. An ACH/Direct deposit form from your bank
- 3. Or an official bank letter from your bank

All three items can be obtained directly from your local bank. Many banks also allow their customers to print an ACH/Direct deposit form directly from their website or personal bank account. If you need assistance accessing this form, please contact the UNCSA Payroll Office or your bank via phone. You may also contact your bank via phone and request items #2 and/or #3 to be sent to directly you.

Bank Statements, Deposit Slips, and Pictures of Debit/Credit cards cannot be accepted.

Please attach requested supporting documentation as a PDF or JPEG document.

If you close your direct deposit account on file with UNCSA Payroll, or you need to change your direct deposit bank account information, please submit new direct deposit information to the Payroll Office as soon as possible so that there is not a delay in your pay.

If your direct deposit account is compromised, please contact the Payroll Office as soon as possible so that your direct deposit can be immediately inactivated, and submit new bank account information to the Payroll Office as soon as possible to avoid delay in your pay.

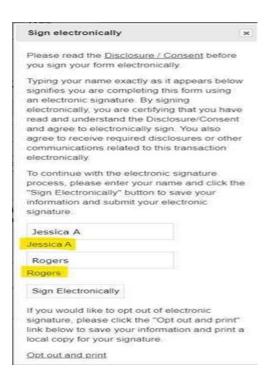

Payroll documents completed through secured links on the Payroll Website are legal documents and must be digitally signed EXACTLY as it appears below the boxes using your legal name.
