Jim DeCristo shared updates on the state budget. The House budget proposal is out, with the Senate budget in process. The Senate budget could possibly be out in a couple of weeks. The House budget proposal is good overall, and we are hopeful, minus the lack of funding requested for Health and Wellness Initiative. The Senate budget might not be as generous. Concerns regarding the economy in future years. Administration will continue communication with representatives, advocating for the Health and Wellness Initiative.

Jim DeCristo also shared an update on funding and timelines of the Stevens Center, all currently on schedule.
