\*The bank letter should be a single page document on bank letterhead showing the criteria below: (Note: DO NOT submit long statements that include transaction history.)

- \*showing bank/financial statements from multiple accounts is acceptable (Certificate of Deposits are NOT acceptable)
- \*indicate the financial institution's name
- \*indicate the account holder's name
- \*clearly show the account balance
- \*be dated within the past 6 months (older statements will not be accepted),
- \*be translated into English (especially names)
- \*clearly show the type of currency converted to U.S. dollars
- \*be from statements that show liquid assets that can be converted to cash
