**Pass requests submitted via Orah are expected to be accurate to the best knowledge of parents/guardians and students. For safety reasons, Parents/Guardians should not share Orah passwords with their students at any time. A Residence Life staff member may override any granted parental permission if the situation does not seem to be consistent with the school's regulations or is deemed not to be in the best interest of the student.**

### 1. UNCSA Provided Permissions

- a. All students are granted permission to walk off campus in groups of two or more. Students must sign in before sunset when walking.
- b. All students are granted permission to go on official UNCOSA Day Trips (ex. Weekly bus trips, field trips, & performances).
- c. All students are granted permission to ride in cars with UNCOSA faculty and staff.

### 2. Off-Campus DAY Trips (to return to campus before curfew of same day.)

Parents/Guardians will connect to their student's Orah account and approve/deny all off-campus day trips not included above.

**For daytime visits to off-campus residences, staff will call the host to confirm an adult will be present. For this reason, host contact information will be required within this pass.**

**(NOTE: High school students will not be allowed to visit college student residences, including siblings.)**

### 3. Transportation Permissions

**Per Lyft and Uber company Terms of Service, only students aged 18 are allowed to create accounts or request/ use their transportation services. Students under age 18 will not be allowed to use Uber/Lyft Car services under a parent account. Students under 18 may ride with an 18-year-old student account owner with parent/guardian permission. Students under age 18 may ride in Taxis within the city of Winston-Salem with parent/guardian approval.**

- a. Taxi /Uber /Lyft or other Car Services (Please check what applies.)

**My student is age 18 years.**

- Has their own Uber/Lyft account and has permission to use Uber/Lyft on passes.
- I will approve or deny any taxi/uber/car services each time a pass is submitted via Orah software.

**My student, is under age 18.**

- Has my permission to ride in a taxi/uber/lyft car service within the city of Winston-Salem with an 18 year old student account owner.
- I will approve/deny taxi services each time a pass request is submitted via Orah software.

- b. Personal Vehicles ( Please check **ONE** item below.)

- I will approve/deny individual drivers each time a pass is submitted via Orah.
- My student may ride in cars at their discretion (with any licensed driver.)

### **Overnight Trips**

All overnight trips must be approved by parents and hosts, if applicable, in Orah. Pass requests should be submitted 48 hours in advance. The Orah pass will count as written permission, but parents and hosts will need to provide verbal permission to a Residence Life Staff Member.

### **College Audition Trips**

Please utilize the "C- College Auditions" pass for college visit departures. All college visits must be approved by parents/guardians via Orah 48 hours prior to staff approval and leaving campus. Students are expected to inform academic instructors of any classes they will miss and submit a form available upon request from the High School Academic Office. Parents/guardians must send an email to the Academic Office to confirm plans. You can also contact the High School Academic Office at 336-770-3245.
